### Who we are

Justice and Care exists to bring freedom to people and communities living in the grip of slavery. We rescue men, women and children who have been brutally exploited. We restore their lives. We fight slavery, pursuing and dismantling criminal networks and bringing perpetrators to justice. We secure communities at risk from traffickers and spark systemic change.

Our programmes includes work in Bangladesh helping to spot victims of human trafficking as they are being taken across borders and the pursuing of those responsible through the courts. In Romania, we are helping to bring victims home and raise awareness about the risks of being trafficked. In the UK, we work alongside police to provide critical support to victims. Our work is always victim centric and focused around how to help create systemic change.

We have a strong track record of impact exceeding:

- 5,063 people rescued
- 1,134 suspected traffickers arrested
- 4,157 survivors supported
- 1,275 exploiters prosecuted
- 51,164 police officers, public prosecutors, and community leaders trained in trafficking awareness

Our work has led to major systemic change in India, Bangladesh and the UK. It is also award winning – in 2020 securing a coveted Thomson Reuters Stop Slavery Award for our work in Bangladesh and the 'Breakthrough of the Year' in the UK's Third Sector Awards for our Victim Navigator Project. In Romania, we have been given a SocNET (Serious Organised Crime Network) Award for our outstanding contribution to counter Modern Slavery and Human Trafficking, and in Scotland we were recently recognised as "Policing Partner of the Year" by Police Scotland.



Justice and Care is an equal opportunities employer. ## Role overview...

We are looking for an outstanding Institutional Programme Funding Principal (ie Senior Specialist) to join our team, with the experience needed to research, apply for and manage large grants from government sources. To be successful in this role you will be an experienced grants and contracts fundraiser who is:

- An outstanding written communicator
   able to explain and inspire, conveying
   complex ideas with clarity and brevity
- Focussed on detail able to ensure coherence across all aspects of project applications (narrative, logframes, budget, gantt chart etc) and reporting
- Knowledgeable with a good understanding of charity governance and best practice and an in-depth understanding of the grants (institutional and trusts and foundations) funding landscape, key trends, opportunities, and challenges

- People orientated You will have the ability to network and communicate at a senior level with potential funders
- Organised an effective project manager able to coordinate across teams to produce collaborative work to deadlines
- Passionate You are passionate about the eradication of human trafficking
- Willing to roll up your sleeves There is lots to be done and you won't be afraid of hard work, working to tight deadlines. A team player, committed to making things work and helping get everything in place to do so
- Someone who takes the initiative a selfstarter, solutions-orientated and a strategic thinker
- Collaborative partnership orientated and committed to our mission of 'joining forces'IT competent - with strong Microsoft 365 (Word, Excel, PowerPoint) skills

### 4 Scope of the job

You will own the development and implementation of the programme funding strategy. Within this you will:

- Oversee the research / scoping and development of all bids for government funding, and for large (>£500K) grants from other sources (eg trusts and foundations)
- Plan and monitor funding and application cycles
- In collaboration with the Global Programme Strategy and Impact and Country Directors, support the design of new programmes, adopting our locally led and owned approach
- Produce high quality applications in response to institutional funding calls, including logical

frameworks, GANTT activity charts, clearly written narrative proposals and detailed budgets

- Negotiate appropriate contracts and terms with funders with care and diligence
- Liaise between impact team, programme leads and finance to monitor and ensure compliance with contract terms
- In coordination with other internal stakeholders, cultivate and manage relationships with the relevant government departments to influence the approach of their funding calls
- Build and manage strong, effective working relationships with existing and new large, multi-year funders, fulfilling funder requirements in a timely manner, including preparation of narrative and financial reports,

- responding to funder queries and regular online and in person meetings with funders as necessary
- Work closely with the Finance Director and senior management to develop robust annual budgeting and financial reporting processes, ensuring grants/ contractual obligations are reflected in annual budgets and budgets are aligned with programmatic and strategic goals, and analyse funding gaps

# Position in the organisation

Sitting within the Global Programme Strategy and Impact team, you will work across the organisation in close collaboration with Country Directors, programme leads, impact team, fundraising team and finance team. You will report to the Global Programme Strategy and Impact Director and provide technical oversight to applications by the Grants Manager and Trust and Foundations Executive. You will form a key part of and input into, the wider Global Income Generation Group.

Purpose of the role

This role will lead on institutional fundraising and bring appropriate technical expertise, as well as strategic vision, to the development of this critical income stream across our global work. This includes leading on institutional funding applications, relationship management, compliance, reporting and more. Institutional income both provides long-term funding at a significant scale, and

an opportunity to increase our advocacy and systemic change influence.



# Main responsibilities

#### Your key responsibilities include, but are not necessarily limited to:

- Lead on the development and implementation of the institutional programme funding strategy, including planning and coordination of applications, reporting, partnership / consortium development and more.
- Research new potential institutional funding opportunities globally (FCDO, J/ TIP, USAID, NORAD etc.) and cultivate relationships with those institutions that can help inform the development of their funding priorities
- Work with the Director of Strategy and Impact, Country Directors and external partners to co-design projects in response to funding calls that align with our global and country strategies
- Develop high quality high value funding applications. This includes co-developing concept notes, proposals, budgets, gantt charts, results monitoring plans etc.
- Lead on institutional donor grant agreement/contract negotiations and compliance

- Account management of institutional funders and large grant giving organisations- including coordinating comprehensive reporting to each funder's requirements.
- Ensure all relevant team members are fully briefed on the terms and conditions of donor grant agreements/contracts, including key deadlines. Manage due diligence processes, facilitate donor audits and ensure compliance with all grant terms.
- Provide technical support to fundraising team members working on large trust and foundation grant applications
- Identify and spearhead organisational improvements necessary to increase eligibility for funding from institutional donors and grant giving organisations
- Keep up to date files and records of all grant funding activities on the filing system and CRM (Salesforce)
