Today, thousands of children will become slaves. Taken to work in brothels, sweatshops, as domestic workers. One every 30 seconds. Do you care about this? As in, really care? If you do, then read on.

Justice and Care exists to bring freedom to people and communities living in the grip of slavery. We help rescue women and children who have been brutally exploited. We empower them to rebuild their lives. We fight slavery, pursuing and dismantling criminal networks and bringing perpetrators to justice. We work to secure communities at risk from traffickers and spark systemic change.

We have a strong track record of impact - with more than:

- **5,373** survivors rescued
- **1,641** arrests made
- 4,957 survivors supported
- 1,783 prosecutions of exploiters supported
- 65,716 police officers, public prosecutors, and community leaders trained in trafficking awareness

Our work has led to major systemic change in India, Bangladesh and the UK. It is also award-winning - securing in 2020 a coveted Thomson Reuters Stop Slavery Award for our work in Bangladesh and the 'Breakthrough of the Year' in the UK's Third Sector Awards for our Victim Navigator Programme. In Romania we have received a SocNET (Serious Organised Crime Network) Award for our outstanding contribution to counter Modern Slavery and Human Trafficking.

Position in the organisation

As Philanthropy Lead, you will report to the Head of Fundraising & Development and take a senior role in the Development Team. You will have support from the Chief Executive, the Board of Trustees and our Ambassador Group - a high-value network of senior volunteers.

You will line manage the Philanthropy Specialist, supporting their growth and ensuring we deliver a joined-up, highperforming philanthropy programme.

Team Purpose

The Fundraising and Development Team is responsible for growing income across a range of streams - philanthropy, corporates, trusts and foundations, and individual giving - to advance Justice and Care's global mission. We build long-term, strategic partnerships and create bold opportunities for others to invest in ending modern slavery.

Role Purpose

You will lead our major donor programme - driving ambitious growth in high five- and six-figure giving, managing a small but growing team, and shaping the future of our philanthropy strategy. You will nurture and expand powerful relationships with new and existing supporters, bring bold ideas to life, and work closely with the Head of Fundraising & Development to unlock the next level of potential in our income and impact.

This is a senior role at the heart of our 10-year vision: to reduce modern slavery in the UK, Romania and Bangladesh by 2035. You will join forces and help bring others into that mission - as investors, ambassadors and advocates for change.

Engagement and Representation


- Act as a senior ambassador for Justice and Care in relevant philanthropic and wealth networks.

- Lead income forecasting with clear visibility of pipeline strength and confidence levels.
- Track performance against targets and provide regular updates to senior leadership.
- Clearly flag income restrictions and emerging risks to support agile organisational planning.

Collaboration and Learning

- Work cross-organisationally to shape proposals, gather impact stories and prepare reports.
- Proactively share learning and insight with colleagues to strengthen team performance.
- Take on other duties as needed to advance the work of the Development Team and the wider organisation.

Justice and Care prioritises Safeguarding.
